# Paid Seminar: Human Rights Due Diligence – What is it and how do we make it work?

While climate change has been at the forefront of the movement towards engaging in sustainable business operations, social issues are now demanding equal attention with discussion on legally obligating companies to institute Human Rights Due Diligence (HRDD), an ongoing process of identifying, preventing, mitigating and accounting for adverse human rights impacts in their supply chains.

In February, the EU introduced potentially ground-breaking legislation which would require all 27 EU countries to implement mandatory HRDD, to cover the entire value chain and establish both liability regimes and strong enforcement mechanisms that hold companies accountable for harms and deter exploitative business practices.

But what is HRDD? How do we approach the creation and development of a framework to cover this and how do we implement across our vast supply chains in a meaningful, effective yet practical and manageable way?
