### Türkiye's April Exports Reach \$25.4 Billion

Türkiye's exports rose 22.3 percent year-on-year in April to \$25.4 billion, Trade Minister Prof. Dr. Ömer Bolat has said



Our exports increased by 22.3% in April, enabling us to achieve the highest April export figure to date. At the same time, we recorded the second-highest monthly export performance in our history. Exports rose by 3% over the first four months and by 4.2% over the past 12 months. Türkiye recorded exports of \$25.4 billion in April. In 2026, exports for the first four months reached \$88.6 billion, while exports over the past 12 months climbed to \$275.8 billion.

All 26 of our sectors increased their exports in April. In the sectoral ranking, automotive maintained its leadership with \$3.9 billion. It was followed by chemicals with \$3.1 billion, electrical and electronics with \$1.8 billion, ready-to-wear apparel with \$1.451 billion, and steel with \$1.438 billion.

The share of these sectors in total exports to EU countries was approximately 30.5%. In the January-April period, Germany received the highest export volume among EU countries. Exports to Germany increased by 7.2% to reach \$6.76 billion. Europe's largest economy was followed by Italy with \$4.5 billion, Spain with \$3.5 billion, France with \$3.48 billion and Romania with \$2.44 billion, respectively.

### Türkiye Aims to Boost Trade, Attract Foreign Investments With New Vision

The new investment framework aims to increase the export of goods and services, bring capital home, and establish Istanbul as a key regional financial centre, according to the Turkish finance minister



The high-level gathering marked a key moment in Türkiye's economic agenda, featuring the announcement of a comprehensive new economic reform package aimed at strengthening the investment climate, reinforcing financial stability, and attracting global capital. President Erdoğan emphasized that Türkiye is taking "legal, administrative, financial,

and institutional steps to enhance our competitiveness, ensure sustainable high growth, and support international direct investment by strengthening the investment environment," adding that the country is determined to transform Türkiye into a "global center of attraction."

Türkiye's Treasury and Finance Minister Mehmet Şimşek, who outlined a comprehensive structural reform agenda focused on industrial transformation, moving up the value chain, green and digital transitions, productivity investments, and enhancing infrastructure such as railways. The minister emphasized that the services sector remains resilient to global trade protectionism and fragmentation; noting that Türkiye already boasts a strong global position with a service export surplus exceeding \$60 billion.

Trade Minister Prof. Dr. Ömer Bolat highlighted key measures taken to support export sectors and draw foreign direct investment. Since 2021, he said, Türkiye has aligned its industrial regulations with the EU Carbon Border Adjustment Mechanism and Green Deal criteria, a landmark policy designed to prevent carbon leakage. The government has coordinated closely with private sector representatives to adapt key industries such as cement, steel, fertilizer, energy and textiles to the new environmental standards, he said. Bolat further said Türkiye has invested roughly \$300 billion in transportation and \$200 billion in energy infrastructure under the leadership of President Recep Tayyip Erdoğan.

Taking advantage of its strategic geographic location, he said, Türkiye has explored alternative trade routes via neighboring countries. Those efforts have borne fruit, he said, adding that the country attracted \$300 billion in foreign direct investment over the last 23 years.

Industry and Technology Minister Mehmet Fatih Kacır said the country eliminated bureaucratic obstacles for establishing digital companies under the Tech Visa program. Kacır stated that international investors can now set up businesses remotely through a passport-based identity verification process. He noted that entrepreneurs gain access to virtual office services and automated accounting infrastructures to reduce operational costs significantly. He said 13,000 companies currently operate across 114 technology parks in Türkiye with state support. He stressed that the nation has opened a new window of opportunity to attract global talent by leveraging its strong entrepreneurship ecosystem and advanced defense industry capabilities. Kacır reported that the Tech Visa program successfully brought over 5,000 digital talents to the country in its first year by granting work permits within two weeks.

He highlighted that digital company members receive special privileges, providing access to a world-class entrepreneurship center under the Terminal Istanbul project. Kacır reaffirmed that green transformation remains a primary strategy as the country actively supports the industrial shift toward renewable energy.

## Türkiye, Syria Ink Deal For Economic Integration

**Two countries aim to reach a bilateral trade volume of \$10B, the Turkish trade minister says**



Turkish Trade Minister Prof. Dr. Ömer Bolat said the protocol signed between Türkiye and Syria as part of the Joint Economic and Trade Committee (JETCO) meeting will act as a comprehensive roadmap for economic integration, regional development and reconstruction. Following the bilateral meeting, Turkish and Syrian officials held the First Term Meeting of the Türkiye-Syria JETCO in Istanbul.

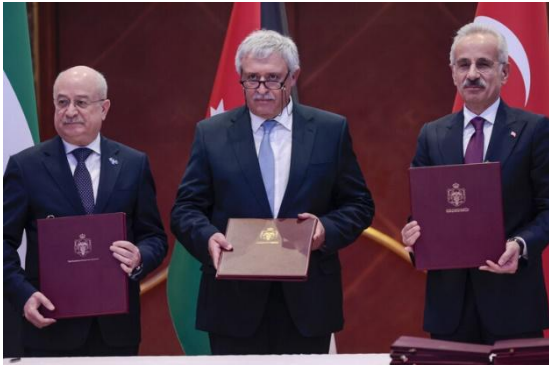
In his statement after the meeting, Bolat noted that there was a historical turning point in economic and trade relations between Türkiye and Syria. He said the first session of JETCO, which they signed in Ankara on August 5, 2025, was completed successfully on the axis of mutual trust. Bolat stated that parties confirmed their determination to reach a balanced and sustainable volume of bilateral trade for the mutual benefit of both nations during the talks. "We discussed all kinds of solutions and mechanisms to bring our bilateral trade, which reached \$3.7 billion last year, to \$5 billion first and then to the \$10 billion target," he added. He noted that while deciding to deepen the cooperation, especially in strategic sectors such as textiles, agriculture, food and machinery, the two countries also agreed to share mutual information on regulatory frameworks to ensure predictability in agricultural trade. "We are also very pleased to bring together the leading companies and investors of both countries with the Türkiye-Syria Business and Investment Forum to be held on the margins of this meeting," he said.

Meanwhile, the two countries signed a cooperation agreement in the fields of product safety and inspection, technical regulations, standardisation, conformity, and metrology during the JETCO meeting.

### **Türkiye, Jordan, Syria Sign Trilateral Deal On Transport to Boost Regional Trade**

**Trilateral mechanism aims to revive North-South corridor, enhance connectivity from Mediterranean to Red Sea**



Türkiye, Jordan, and Syria signed a trilateral memorandum of understanding on transport cooperation, aiming to strengthen regional connectivity and boost trade across a key North-South corridor. Turkish Transport and Infrastructure Minister Abdulkadir Uraloğlu said the initiative reflects a shared commitment to regional development and prosperity. "This is not merely a technical meeting on transport, but a strong declaration of will for the welfare of our peoples and regional development," Uraloğlu said,

emphasizing the importance of political and economic stability supported by efficient logistics.

He noted that activating the Türkiye-Syria-Jordan axis at full capacity would significantly increase export potential and transit revenues for all three countries, creating a multiplier effect for regional economies. Uraloğlu highlighted the strategic importance of establishing a fully functional North-South transport corridor, supported by modernized road and rail infrastructure. He also underscored the need to reduce transit fees, taxes, and additional costs to facilitate smoother cross-border transportation. The minister said that the trilateral mechanism would help remove barriers facing transport operators, expand opportunities in rail transport, and revitalize ports, ultimately contributing to sustainable trade growth. He further pointed to the integration of maritime routes, noting that Türkiye and Syria's Mediterranean port capacity, combined with Jordan's strategic access to the Red Sea via the Gulf of Aqaba, should be evaluated as a unified logistics network.

### Türkiye Signs With World Bank to Finance Major Istanbul Rail Crossing Project

**INRAIL project to increase freight capacity across Bosphorus Strait from 3M to 50M tons annually, create higher-income employment for over 400,000 workers**



Türkiye signed a €1.67 billion (\$1.9 billion) financing agreement with the World Bank for the Istanbul North Rail Crossing (INRAIL) project, aimed at strengthening intercontinental trade routes. Turkish Treasury and Finance Minister Mehmet Şimşek said the deal is the third-largest project ever approved by the World Bank, adding that the overall project is backed by \$8.1 billion in total financing, about 83% of which comes from international institutions.

The INRAIL project involves the construction of a 127-kilometer (78.9-mile) electrified high-capacity railway line crossing the Bosphorus Strait via the Yavuz Sultan Selim Bridge, bypassing the Istanbul metropolitan area. It is expected to significantly increase freight and passenger rail capacity, reduce logistics costs, connect Istanbul's two airports to each other and to the national rail network, and enhance key national and intercontinental transport corridors. Once operational, it is expected to increase annual rail freight capacity across the strait from 3 million tons to 50 million tons. Şimşek added that the INRAIL project will remove one of the "most critical bottlenecks" along the Middle Corridor, which is the fastest trade route connecting Beijing to London, with a transit time of just 18 days.

Türkiye's transport infrastructure development has attracted \$355 billion in investment over the past two decades, including \$180 billion in road projects, as well as expansion of the airport network.

### IEA, IMF, World Bank Warn Fuel, Fertilizer Prices May Stay High For Prolonged Period

**Institutions say shipping disruptions, infrastructure damage from Mideast war could keep prices elevated even if Hormuz flows resume**



The International Energy Agency (IEA), the International Monetary Fund (IMF) and the World Bank Group warned Monday that fuel and fertilizer prices could remain elevated for an extended period even if normal shipping flows through the Strait of Hormuz resume, citing supply chain damage and delays in restoring global commodity flows. In a joint statement, the three institutions said the impact of the Middle East war is "substantial, global, and highly asymmetric," disproportionately affecting energy importers, particularly low-income countries.

### Türkiye Launches Saudi Transit Trade Route For Goods Disrupted By Hormuz Crisis: Trade Minister

**Turkish commercial trucks to resume overland shipments via Saudi Arabia to broader Gulf region amid paralyzed maritime trade due to Middle East conflict, positioning Türkiye as vital, stable logistics bridge, says Turkish trade minister**



Türkiye has launched transit trade with Saudi Arabia to keep shipments moving to regional countries amid disruptions in the Strait of Hormuz, Trade Minister Prof. Dr. Ömer Bolat announced. Bolat said products unable to pass through the strategic waterway would be redirected through alternative logistics channels. "We have launched transit trade through the agreement made with Saudi Arabia. With this, products that cannot

pass through the Strait of Hormuz will continue to reach countries in the region, some through pipelines and some through road transportation," he said.

Bolat said transit visas are now being issued under the arrangement with Saudi Arabia, adding that the move would help sustain trade flows across the Gulf region. The resolution to the visa issue comes at a key moment for global supply chains amid ongoing military conflicts in the Middle East paralyzing maritime trade. Bolat stated that overland logistics through Türkiye have become more vital than ever in the current environment, as the country serves as a natural geographic bridge to Eurasia.

He said Türkiye has made major advances in logistics and now has a logistics sector worth \$112 billion. On agriculture, Bolat said Türkiye has sufficient stocks, particularly in food products, and expects record output in nearly all products this year if there is no frost risk.

### Türkiye Signs Zero Waste Deal to Curb Transport Emissions

**The agreement will promote zero waste principles across transport and infrastructure and strengthen resource efficiency and circular economy practices, Transport Minister Abdulkadir**



Türkiye has signed a cooperation protocol with the Zero Waste Foundation, marking a new step in the country's efforts to embed sustainability across its transportation sector. Uraloğlu announced that the agreement would raise waste management standards across transportation projects to the highest level. "We will increase the use of recycled materials in construction and maintenance processes, make zero waste practices standard at our ports, airports and stations, and spread awareness of sustainable

transportation to our passengers, employees and all stakeholders," he said.

Uraloğlu highlighted the scale of the challenge, noting that the transportation sector accounts for roughly 21 percent of greenhouse gas emissions globally, the third largest contributor, and 17.6 percent domestically, making it Türkiye's second largest emitting sector. "These figures clearly demonstrate that the transportation sector has a critical role to play in the fight against climate change," he said.

On aviation, Uraloğlu noted that the country now ranks second globally, behind only the United States, in the number of airports holding carbon-free certification under the Airport Carbon Accreditation Program, with 52 certified airports.

The first, the Zero Waste Forum, is scheduled for June 5–7 and is expected to draw representatives from more than 150 countries, over 100 ministers, and upwards of 5,000 participants, with backing from organisations including the World Bank, the United Nations, and leading universities such as Harvard and Cambridge. Türkiye is also set to host COP31 later this year.

### Türkiye Aims to Enter Top 10 in Global Defense Exports: President Erdoğan

#### Recep Tayyip Erdoğan says Türkiye targets \$11B in defense and aerospace exports in 2028



Recep Tayyip Erdoğan said “Türkiye’s main defense industry objective in the days ahead is to produce high-tech products more quickly, more effectively, and in greater quantities, vaulting it into the global top 10 of defense exporters. Türkiye aims to reach its target of \$11 billion in defense and aerospace exports in 2028, putting it in the ranks of the world’s top 10 in defense exporters.”

Erdoğan also said Türkiye’s defense exports have ballooned from just \$248 million in 2002 to over \$10 billion last year. In the first quarter of 2026, he said, defense and aerospace exports rose 12.1% from a year earlier to \$1.91 billion.

Türkiye’s defense and aviation exports in the first four months of the year topped \$2.8 billion, jumping 28% from the same period last year, Trade Minister Prof. Dr. Ömer Bolat. Bolat said Türkiye’s defense and aviation exports had climbed from \$248 million over the past two decades to \$10.05 billion last year alone. “This year, we have a 28% increase in the first four months. We topped \$2.8 billion,” Bolat said, adding that last year the sector passed the \$10 billion export threshold for the first time. Bolat described SAHA 2026 as one of Türkiye’s most advanced fairs in industry and technology, saying the event showcases the country’s strongest products in industry, technology, science, and telecommunications. Bolat said Türkiye’s defense and aviation ecosystem includes 3,500 companies and nearly 100,000 highly qualified workers and research and development personnel.

The head of the Turkish Defense Industries Secretariat Gorgun said that over the past 20 years Türkiye’s defense industry has achieved a localization rate of more than 80%, adding that the country now develops products and platforms across all major defense domains, including land, air, naval, submarine and space systems. He said Türkiye not only produces platforms, but also develops their subsystems, munitions, and logistics systems.

## Concentrated Critical Mineral Supply, Rising Protectionism Threaten Global Economy: Turkish Minister

### Bolat warns lithium, cobalt dependency creates vulnerabilities in 'twin transition' era



The geographic concentration of critical minerals and rising protectionism in trade pose serious risks to global economic security, Turkish Trade Minister Prof. Dr. Ömer Bolat said. Speaking at the OECD Critical Minerals Forum in Istanbul, Bolat said state intervention, export restrictions, and the weaponization of supply chains have become defining features of an increasingly fragmented global economy.

“Geopolitical tensions are not only on the rise but also are becoming increasingly more complex and persistent, while regional conflicts continue disrupting trade routes and driving up costs, hampering predictability,” Bolat said, describing the current environment as a structural transformation driven by efforts to secure resources for the "twin transition" toward clean energy and digitalization. Critical minerals are essential to modern technologies, including electric vehicle batteries, wind turbines, solar panels, semiconductors, data centers, and advanced artificial intelligence systems. Bolat said global demand for lithium has surged fourfold over the past decade, fueled by the expansion of renewable infrastructure and advanced electronics, with further acceleration expected.

According to Bolat, this lack of diversification creates strategic vulnerabilities for importing countries while trapping producers in structural inequality when they rely on extraction without technology transfer or infrastructure investment. He also called for stronger investment in the circular economy, including recycling, efficiency, and battery innovation to reduce dependency.

## Türkiye's Tourism Income Climbs 4.2% in First Quarter

### Country earns nearly \$9.9B from tourism in January-March period, while number of departing visitors climbs 1.5% to 9.3M



Türkiye's tourism income rose 4.2% year-on-year in the first quarter of 2026 to nearly \$9.9 billion, with \$9.69 billion coming from visitors and \$201.9 million from transit passengers, according to TurkStat data. The Turkish cruise tourism sector posted a 16-year high during March, with 41,039 passengers being drawn to coastal hubs amid a rise in global cruise travel demand. Transport and Infrastructure Minister Abdulkadir Uraloğlu said Türkiye hosts nearly 94,000 cruise passengers in Q1, with Istanbul attracting most nationwide

traffic from January–March, while the cruise passenger count rose 4.9% year-on-year.

Formula 1 will return to Türkiye after a six-year absence, with the Turkish Grand Prix included on the 2027 calendar of the world’s premier motorsport series. Erdoğan said Türkiye, which he described as “a country of motorsports,” aims to deepen its partnership with Formula 1 in the coming years.
